

RESOLUTION NO. 2009-4

PROVIDING FOR THE REAPPOINTMENTS OF SANDRA ROBERTS TO THE CIVIL SERVICE COMMISSION, JOHN KLASMEIER TO THE CHARTER REVISION COMMITTEE, AND ROBERT MILLER TO THE BOARD OF TAX REVIEW

WHEREAS, a vacancy on the Civil Service Commission will occur on July 1, 2009, by reason of the method of appointment prescribed in Section 10.03 of Article X of the Charter of Blue Ash; and

WHEREAS, Sandra Roberts, 32 Carpenter's Run Court, has expressed a desire to continue serving on this Commission; and

WHEREAS, a vacancy on the Charter Revision Committee will occur on July 1, 2009, by reason of the method of appointment prescribed in Sec. 22.02 of Article XXII of the Charter of Blue Ash; and

WHEREAS, John Klasmeier, 10864 Wengate Lane, has expressed a desire to continue serving on this Committee; and

WHEREAS, Section 171.13(a) of the Codified Ordinances of the City of Blue Ash provides for appointments to and the filling of vacancies on the Board of Tax Review of the City; and

WHEREAS, a vacancy on said Board will occur due to the reason of the method of appointment prescribed in said Section; and

WHEREAS, Robert Miller has expressed an interest in continuing to serve on said Board.

Be it resolved by the Council of the City of Blue Ash, Ohio,

SECTION I.

Sandra Roberts, an elector of the City of Blue Ash, Ohio, residing at 32 Carpenter's Run Court, Blue Ash, Ohio 45241, is hereby reappointed as a member of the Civil Service Commission of the City of Blue Ash, Ohio. The term of said appointment shall commence on July 1, 2009, and shall expire on July 1, 2012, unless the appointee shall for any reason become disqualified for said term prior to its expiration.

SECTION II.

John Klasmeier, residing at 10864 Wengate Lane, Blue Ash, Ohio 45241, is hereby reappointed as a member of the Charter Revision Committee of the City of Blue Ash, Ohio. The term of said appointment shall commence on July 1, 2009, and shall expire on July 1, 2014, unless the appointee shall for any reason become disqualified for said term prior to its expiration.

SECTION III.

Robert Miller, residing at 4 Hickory Hollow, Blue Ash, Ohio 45241, is hereby reappointed as a member of the Board of Tax Review of the City of Blue Ash, Ohio. The term of said appointment shall commence July 1, 2009, and shall expire on July 1, 2012, unless the appointee shall for any reason become disqualified for said term prior to its expiration.

SECTION IV.

The Clerk of Council shall forthwith mail or otherwise cause to be delivered to the appointees named herein a copy of this resolution.
