

RESOLUTION NO. 2010-5

PROVIDING FOR THE REAPPOINTMENTS OF STEVE RICHTER TO THE CIVIL SERVICE COMMISSION, RICH COGEN TO THE CHARTER REVISION COMMITTEE, AND ARNOLD STOLLER TO THE BOARD OF TAX REVIEW

WHEREAS, a vacancy on the Civil Service Commission will occur on July 1, 2010, by reason of the method of appointment prescribed in Section 10.03 of Article X of the Charter of Blue Ash; and

WHEREAS, Steve Richter, 9351 Lansford Drive, has expressed a desire to continue serving on this Commission; and

WHEREAS, a vacancy on the Charter Revision Committee will occur on July 1, 2010, by reason of the method of appointment prescribed in Sec. 22.02 of Article XXII of the Charter of Blue Ash; and

WHEREAS, Rich Cogen, 4480 Classic Drive, has expressed a desire to continue serving on this Committee; and

WHEREAS, Section 171.13(a) of the Codified Ordinances of the City of Blue Ash provides for appointments to and the filling of vacancies on the Board of Tax Review of the City; and

WHEREAS, a vacancy on said Board will occur on July 1, 2010 due to the reason of the method of appointment prescribed in said Section; and

WHEREAS, Arnold Stoller has expressed an interest in continuing to serve on said Board.

Be it resolved by the Council of the City of Blue Ash, Ohio,

SECTION I.

Steve Richter, an elector of the City of Blue Ash, Ohio, residing at 9351 Lansford Drive, Blue Ash, Ohio 45242, is hereby reappointed as a member of the Civil Service Commission of the City of Blue Ash, Ohio. The term of said appointment shall commence on July 1, 2010, and shall expire on July 1, 2013, unless the appointee shall for any reason become disqualified for said term prior to its expiration.

SECTION II.

Rich Cogen, residing at 4480 Classic Drive, Blue Ash, Ohio 45241, is hereby reappointed as a member of the Charter Revision Committee of the City of Blue Ash, Ohio. The term of said appointment shall commence on July 1, 2010, and shall expire on July 1, 2015, unless the appointee shall for any reason become disqualified for said term prior to its expiration.

SECTION III.

Arnold Stoller, residing at 5779 Bomark Court, Blue Ash, Ohio 45242, is hereby reappointed as a member of the Board of Tax Review of the City of Blue Ash, Ohio. The term of said appointment shall commence July 1, 2010, and shall expire on July 1, 2013, unless the appointee shall for any reason become disqualified for said term prior to its expiration.

SECTION IV.

The Clerk of Council shall forthwith mail or otherwise cause to be delivered to the appointees named herein a copy of this resolution.
