MEMBERSHIPS and FEES

Memberships – Admittance to the Recreation Center requires members to show their membership card. This card is received after membership purchase and *must* be carried to the Center at all times. If a card is forgotten, a guest fee will be charged. Only Blue Ash residents and those who work full-time within Blue Ash are eligible to purchase Recreation Center memberships. The entire fee must be paid at the time of purchase, and proof of residency or full-time employment in Blue Ash must be shown at the time of purchase or renewal. Memberships expire one year from the date of purchase. Basic membership to the Recreation Center includes the use of the swimming pools, gymnasiums, daily use of lockers, and racquetball courts (with \$2 hour court fee). Additional fees are charged for the use of fitness center, racquetball reservation privilege, locker rental, and tennis courts. **See details below.**
